Notice is hereby given that the County Council of Pierce County, Washington, will hold an open public hearing at a regular meeting of the Council scheduled for Tuesday, December 18, 2018, starting at approximately 3:00 p.m. in the Chambers of the Pierce County Council, Tenth Floor, County City Building, 930 Tacoma Avenue South, Room 1045, Tacoma, Washington, to consider the issuance by the Economic Development Corporation of Pierce County (the "Development Corporation") of its Nonrecourse Revenue Bonds (Tool-Gauge & Machine Works, Inc. Project) Series 2019, in an amount not to exceed \$10,000,000. Proceeds of the Bonds will be used to finance the acquisition, construction, and equipping of a 78,959 square-foot manufacturing facility owned, operated and managed by Tool-Gauge & Machine Works, Inc. (the "Company") located at 4336 South Adams Street within the City of Tacoma and within Pierce County. The Bonds will be payable solely from money and security provided by the Company and will not be an obligation of the Development Corporation or any other public agency. NO PUBLIC FUNDS OR CREDIT MAY BE USED TO PAY THE DEBT SERVICE ON THE BONDS WHICH ARE NONRECOURSE TO THE DEVELOPMENT CORPORATION OR PIERCE COUNTY.
