

**MINUTES
HUMAN SERVICES COMMITTEE
February 19, 2019**

1. **Call to Order:** The Human Services Committee meeting was called to order at 9:32 a.m. by Chair Ladenburg.

2. **Roll Call:**
The Clerk called the roll.

3. **Approval of Agenda:** Richardson moved approval of the Agenda as presented; Chair Ladenburg moved Item 7. precede Item 5. on the agenda; motion seconded and passed, as amended, on a voice vote.

4. **Approval of Minutes:** Richardson moved approved of the January 15 and January 25, 2019, minutes of the Human Services Committee as presented; motion seconded and passed on a voice vote.

7. **Help Me Grow:**
Escareno introduced the topic and Kate Ginn, Help Me Grow Manager.

Ginn presented Help Me Grow Pierce County (a 5-year pilot program to develop a comprehensive system of support for families of children from prenatal through age 5) by way of a PowerPoint presentation (contained in the meeting file as Handout No. 1) and responded to questions of committee members.

5. **Proposal No. 2019-6, Prenatal to 25 Commission for Child, Youth, and Young Adult Development:**

Escareno provided opening remarks and outlined the specifics of the proposed new Code Chapter.

The Clerk read the title summary into the record. Discussion and questions followed.

Chair Ladenburg called for public comment. Sharon Hanek and Brenda Milewski addressed the committee. Priscilla Licisich provided written comment (contained in the meeting file as Handout No. 2).

Campbell moved to forward Proposal No. 2019-6 to the full Council with a Do Pass recommendation; motion seconded and passed on a voice vote.

6. Proposal No. R2019-15, Prenatal-To-Three Policies:

The Clerk read the title summary into the record. Escareno introduced the topic and explained the Proposal. Committee members Young and Richardson provided comment, and Ginn responded to questions of Richardson.

Chair Ladenburg called for public comment. Sharon Hanek and Brenda Milewski addressed the committee. Young clarified the intent of the Proposal and urged adoption.

Campbell moved to forward Proposal No. R2019-15 to the full Council with a Do Pass recommendation; motion seconded and passed on a voice vote.


